Your application to replace the organisation's constitution and to change the name of the organisation received by this office on 23 January 2017 has reference.


The replacement of the constitution and the change of name has been approved with effect from 13 March 2017.

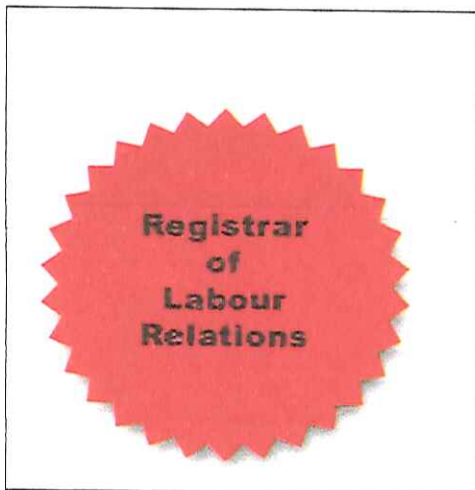




